#### **Minutes**

Meeting Open – 7:00pm

#### 1. Welcome

Welcome to all members present. A quorum was reached. Attendance at the meeting was recorded on the Attendance Meeting Register.

#### 2. Apologies

#### 3. Confirm the minutes of the 2018 A.G.M. held 4th December 2018

No amendments were noted. Alan Glixman called for a motion to accept the minutes as a correct record which was moved by Jon Betts and seconded by Richard Brock. The motion was CARRIED.

#### 7. Election of Life Members

The nominations (below) for each nominee were read out. Nominees were then asked to temporarily leave the meeting whilst their nominations were voted upon.

#### **Scott Greuter**

(Nomination by Alan Glixman)

"Scott has been associated with the club since 1977 when he joined as an U8. As an adult he coached his children's teams for 10 consecutive years from 2006 to 2015. During this time, he also became a member of the club committee and remained there for an extraordinary 16 years from 2001 to 2016, holding the senior role of Vice President for 14 years from 2003 onwards. During this time for 10 long years from 2007 to 2016, he also held one of the most difficult, contentious and stressful roles in the club – Mixed (boys) teams grading coordinator. In addition to this for 6 years Scott was a junior age coordinator.

Scott has given outstanding service to Seaforth Football Club. His constant effort, loyalty, contribution and dedication is even more remarkable when you realise that for much of his time on the committee, during the winter playing season, week in-week out, Scott played his football with his mates at Manly Vale. Despite his strong connection with that club he nevertheless was totally committed to making Seaforth FC a great place for its players and members.

Scott is highly deserving of life membership."

Steve Harding called for a motion that Scott be awarded life membership of the club. This was moved by Andrew Bustos and seconded by Ant Depree. The motion was CARRIED.

## Linda Wright

(Nomination by Richard Wright)

"Linda joined the committee in 2006 as Treasurer with the retirement of Robert Carollo until her retirement in 2016 (10 years).

In 2007 she also took on the role of Canteen Manager until 2016 (9 years). She only took on this role as we were unable to find a Canteen Manager, however, during that time she built the canteen into one that was the envy of many other MWFA clubs.

With the establishment of the new clubhouse and the introduction of a liquor licence she could be seen on any Saturday manning the upstairs bar, and cooking food which was available for both spectators & players of ANY team. This would mean that Linda would be at the club canteen/Clubhouse from 7am till after 7pm on Saturdays. This continued between 2007 & 2016 (9 years).

She would also return from Sanctuary Point, after caring for her ill father to make sure she would fulfil her commitments to the club.

Between 2007 – 2016 we held Ladies/Sponsors day. Linda would do the catering for this event, including lots of homemade food. This event was basically held to thank our sponsors and the ladies for their support during the year. She would usually cater for around 100 people (sometimes more). Linda also for many years organised the annual gear collection for kids in Cambodia.

Lastly, I would like to say that in my 15 years as President of the club I could not have done it without the support of Linda.

She was a wonderful supporter and committee person whose commitment and dedication to Seaforth football club is unmatched.

In 2010 she was awarded Seaforth FC "Club Person of the Year". In 2016 she was awarded the MWFA Meritorious Service Award.

Linda is highly deserving of life membership."

Alan Glixman called for a motion that Linda be awarded life membership of the club. This was moved by Catriona Ormond and seconded by Mitch Wright. The motion was CARRIED.

Noted that two (2) "Elected" Director/Management Group positions had become vacant immediately prior to the AGM and were open for election. The "Elected" Director/Management Group positions that were declared vacant and had become open were:

VP, Gear and Grounds became vacant as Steve Harding was required to resign from that "elected" role in order to be eligible to be elected into the President role – ie. in order to comply with the constitutional requirement that an individual can only hold one "Elected Director" role.

VP, Sponsorship and Marketing became vacant as Kristjan Porm resigned after one year in the role.

It was confirmed that none of the other "Elected Directors" terms of office (of 2 years) will expire at this AGM.

#### Voting

Alan Glixman advised the meeting that single formal nominations had been received for the President role (from Steve Harding) and the Manager, Women's Football role (from Emma Ten Kate) roles. So, as per the constitution, as there were no other formal nominations

submitted for the roles no contest was required so no voting for those positions was required and those people were duly declared as elected to those positions.

Congratulations were extended to Steve Harding for commitment and service to the club in stepping up into this prestigious role.
