Meeting Open - 7:10pm

Welcome

Welcome to all members present. Attendance at the meeting was recorded on the Attendance Meeting Register. A quorum was reached.

Noted that this is the AGM for the 2022 season, the meeting having been postponed in November 2022 due to the ill health of the club Secretary Alan Glixman .. who is now recovered.

- There were various matters about which the club will approach Northern Beaches Council:
 - o Establishing recycling facilities at Seaforth Oval
 - Access to the Disabled Toilet at Seaforth Oval
 - Remedial works to correct the damaged stormwater drainage pipes at the north and south sides of Seaforth Oval
- Agreed that at Tania Park that we replace the older flip-up type mini-goals with the newer stronger framed mini-goals.
